CIRCULATION OF ELECTIONS SCHEDULE.

10th July 2019

Issuance of Election Schedule to the valid members of the Association. It will also be displayed at the notice board of the head office and Regional offices of the Association. Displayed at the website of the Association; and Submitted to the Regulator of MoC.

CHANGE OF NAME OF REPRESENTATIVE

13th July 2019

The members desiring to change their Representative shall intimate changes regarding Name Of representative to the Secretary of the association along with necessary proof of eligibility.

PROVISIONAL LIST OF MEMBERS

17th July 2019

The Secretary of Association shall issue and display the provisional list of all members eligible to vote along with their national tax number, sale tax registration number, if applicable, the name and national identity card number of their representative. The list shall be displayed at the notice board of the head office and regional offices of the Association and the website of the Association.

SUBMISSION OF OBJECTION IN PROVISIONAL MEMBERS LIST

24th July 2019

The members who have any objection to the entries in the list of voters shall send their objections in writing to the Secretary.

AMMENDMENT MADE IN THE PROVISIONAL LIST OF MEMBERS IF ANY

27th July 2019

The Secretary will issue the amended list of members if any.

REPRESENTATION TO ELECTION COMMISSION OF AGGRIEVED MEMBERS

30th July 2019

Any person aggrieved by the decision of the Secretary may make a representation, to the Election Commission which shall decide the presentation.

TO REGULATOR OF AGGRIEVED MEMBERS

2nd August 2019

Any person, aggrieved by the decision of the Election Commission or in case the Election Commission fails to decide the representation within the period provided in sub-rule (6), may, within three days of decision by the Election Commission or, as the case may be, on expiry of limitation of the Election Commission under sub-rule (6), make an appeal to the Regulator who shall decide the appeal within ten days and his decision in this regard shall be final.

FINAL VOTER'S LIST OF MEMBERS.

5th August 2019

After the decision of Regulator, the final voter's list shall be

- (a) Displayed at the notice board of the head office and regional offices of the Association
- (b) Displayed at the website of the trade organization and
- (c) Submitted to the Regulator.

Provided that if no appeal has been filed to the Regulator the final list of voters shall be displayed Within fifteen days of the decision of the Election Commission under sub-rule (6)

SUBMISSION OF THE NOMINATION PAPERS FOR FIVE SEATS.

The nomination paper duly proposed and seconded by a registered voter signed by the candidate may submit to the Secretary PCMA upto 5:00 p.m.

9th August 2019

LAST DATE OF RECEIVING OF THE NOMINATION PAPERS.

Last date of receiving of nomination papers for the Election of Executive Committee upto 5:00 p.m

16th August 2019

SCRUTINIZED OF THE NOMINATION PAPERS.

The nomination papers shall be scrutinized by the election commission and list of candidates shall be displayed on the notice board.

17th August 2019

OBJECTIONS IN NOMINATION PAPER IF ANY

The objections, if any, to the nomination of the candidates can be filed to the Election Commission within twenty-four hours of issuance of the list of candidates, Which shall be Decided by the election commission on same day.

19th August 2019

REPRESENTATION TO REGULATOR OF AGGRIEVED PERSON IF ANY

If the Commission fails to decide the stipulated time provided in sub-rule (12),any Candidate aggrieved by the decision of the election commission or, as the case may be, On expiry of limitation of the Election Commission under sub-rule (12) may file an appeal To the Regulator, who shall decide the case and his decision in this regard shall be final.

Within three days of the polling as provided, any person elected as member of Executive Committee Shall send his nomination for election as an office bearer (Chairman, Senior Vice Chairman, Vice Chairman duly proposed and seconded by an Elected Executive Committee member and signed by the candidate to the Election Commission upto 5:00 p.m.
